CHAPTER A-11.1

ANIMAL HEALTH AND PROTECTION ACT

ANIMAL PROTECTION REGULATIONS

Pursuant to section 16 of the *Animal Health and Protection Act* R.S.P.E.I. 1988, Cap. A-11.1, Council made the following regulations:

1. The following forms are prescribed: Forms
 - (a) an order to an owner pursuant to subsection 12(1) of the Act shall be in Form 1 of the Schedule;
 - (b) the consent of the owner for the destruction of an animal shall be in Form 2 of the Schedule;
 - (c) the notification to the owner regarding animals removed or destroyed by an inspector shall be in Form 3 of the Schedule. (EC71/90)

2. (1) The following persons may be appointed inspectors for the purposes of the Act: Inspectors
 - (a) any person licensed to practice clinical veterinary medicine under the *Veterinary Profession Act* R.S.P.E.I. 1988, Cap. V-3;
 - (b) any person authorized by the Prince Edward Island Humane Society to perform the functions of an inspector;
 - (c) any police officer;
 - (d) any other person deemed by the Minister to be qualified to perform the functions of an inspector. (EC71/90)

3. Revoked by EC156/05. (EC71/90; 156/05) Expenses

4. (1) With respect to animals kept for sale, hire or exhibition, the standards of design, construction and maintenance of facilities and the standards of care with which chickens, pigs, veal calves, mink, foxes and dairy cattle respectively shall be maintained, shall be those contained in the following Recommended Codes of Practice published by Agriculture Canada, as amended from time to time: Standards
 - Recommended Code of Practice for Handling Chickens from Hatchery to Slaughterhouse;
 - Recommended Code of Practice for Care and Handling of Pigs;
 - Recommended Code of Practice for Care and Handling of Special Fed Veal Calves;
 - Recommended Code of Practice for Care and Handling of Mink;
 - Recommended Code of Practice for Care and Handling of Ranched Fox;

Recommended Code of Practice for Care and Handling of Dairy Cattle.

Idem

(2) With respect to the humane treatment of animals during transport, the standards of care shall be those contained in Part XII, Transportation of Animals, of the Regulations under the *Animal Disease and Protection Act* (Canada) R.S.C. 1985, Chap. A-11. (EC71/90)

Scientific research

5. With respect to the use of animals for the purposes of medical or scientific research, the standards of care shall be those contained in the Guide to the Care and Use of Experimental Animals, Volumes I and II, published by the Canadian Council on Animal Care, 1984. (EC71/90)

Contents of notice of appeal

6. An appeal under subsection 13.1(1) of the Act shall

- (a) be signed and dated by the appellant;
- (b) specify the order which is the subject of the appeal;
- (c) specify the grounds of appeal on which the appellant relies and the nature of the relief sought; and
- (d) set out the name, address and telephone number of the appellant.
